- 2. Concerns about Watershed-Stakeholders were given an opportunity to share their concerns about their sections of the watershed. Together, the group formed a list that included the following issues:
 - Log jams and beaver dams along the creek.
 - Tree removal and clearing debris.
 - Current and future development in the watershed and its affect on stream health.
 - Stormwater
 - Too much runoff and not enough infiltration and recharge.
 - Non-point source pollution

- Volume of stormwater channeled into creek leading to stream bank erosion and sedimentation.
- Fecal coliform, nutrients and sediment and other pollutants.
- The ecological condition of the lands adjacent to the creek as well as the natural areas throughout the watershed, protecting quality of open space and the need for a healthy stream corridor.
- Need for improved recreation and education opportunities on public land in coordination with Kane County.
- Lack of education for land owners along creeks, need to encourage stream corridor best management practices.
- **3. Develop Goals for the Watershed**-Amy led stakeholders in the process of developing Watershed Plan goals from the list of concerns. She introduced some draft goals to get the discussion started, and the group worked to add and amend them to fit their desires for the watershed. These goals will continue to develop as the Plan does, and include the following:
 - Reduce fecal coliform contributions in Ferson-Otter Creek Watershed
 - Reduce nutrients, sediments, and other pollutants.
 - Educate stakeholders (residents, public official, etc.) about the importance and best management practices of proper watershed stewardship.
 - Promote land use practices that do not increase the volume of stormwater runoff and reduce the risk of flood damage.
 - Improve the quality and quantity of our water supply.
 - Improve stream bank stabilization, erosion protection and conveyance.
 - Formulate or identify a Watershed Coalition that is responsible for continuing efforts in the watershed.

These draft goals will be revisited at the November meeting as an agenda item.

- **4. Stream Walk Opportunity**-Stakeholders discussed a visit to various sites along the Ferson and Otter Creeks. This will give any interested stakeholder the opportunity to see –or show—a problem area or point of interest. More information will be disseminated via email.
